- **A.** Any company/firm engaged in manufacturing and processing and assembling activities and other industrial activities and commodities or any such products used by the common man/industries in India or in any other country shall be treated as General Member.
- B. Any Company/Firm Involve in IT Industries or Software Development shall be treated as General Member.
- **C.** Any company/firm/individual engaged in imparting services like consultancy and other professional services shall be treated as Associates Members.
- D. The Organizations with a turnover of 250 CR & above and MNC's shall be treated as a Corporate Member.
- **E.** The Screening Committee can also enroll as members such individuals who in opinion of SC have contributed or are competent to contribute their Services for the benefit and performance of the objective of the society shall be applicable for financial year Membership shall automatically terminate on the 31st March.
- **F.** The SC can also enroll life members as well as patrons of the society.
